## LIMITING IN-PERSON PUBLIC PARTICIPATION

## AT CITY OF TECUMSEH COUNCIL MEETINGS AND TECUMSEH UTILITY AUTHORITY MEETINGS

These are unprecedented times. The President of the United States, the Governor of Oklahoma and the Mayor of Tecumseh has declared a State of Emergency as a result of the threat of COVID-19 (aka the "Coronavirus"). The Governor and the Mayor both direct citizens to follow public health directives including canceling all gatherings of ten (10) people or more. The Oklahoma Legislature passed and the Governor signed Senate Bill 661 regarding teleconferencing and videoconferencing requirements and allows local legislative bodies to hold their meetings without complying with the normal requirements of in-person public participation.

The health and well-being of our residents is the top priority for the City of Tecumseh and you are urged to take all appropriate health safety precautions. To that end, ON A TEMPORARY BASIS and UNTIL FURTHER ORDER OF THE MAYOR, only members of the governing body and essential staff will be allowed into the Council Chambers during the Tecumseh Council meetings. Also, UNTIL FURTHER ORDER OF THE MAYOR, members of the public will not be allowed into the Council Chambers during the Tecumseh Council meetings.
