1) <u>3RD ITEM ON AGENDA</u> Brittany McEwin (Experience Church) is requesting a Certificate of Appropriateness for **117** N Broadway, Tecumseh, Oklahoma. They are requesting approval to Reduce/Replace Windows and Replace one door with a double door entryway. They are also requesting to

paint the brick on the building the Sherwin-Williams historical color Downing Sand (SW2822) and replacing the existing awning with one the shade of Sherwin-Williams historical color Roycraft Pewter (SW2848).

DISCUSSION: Brittany McEwin spoke for the item. She stated that there are currently 2 single doors on the building, and since they are going to be a church said that the ability to have double doors on one side would allow them to more easily host funerals. The other door will remain from when the building was at one time split into 2 separate buildings, but now that door will just lead to the office. Afentul asked which door was being turned into the double. McEwin stated that it would be the North doors. McEwin stated that when they put in the double doors that they will have to remove one window and the remaining window will be closer to the double door side. Commissioners then asked if they'd had a structural engineer look at the building. McEwin stated that yes they've had a structural engineer working for them during their whole remodel. They found that during the repair to the flooring that there was no support left for the building and that if they hadn't fixed it the building and the ones next to it would have probably collapsed in the next couple years. The building now has a very solid very thick concrete floor. Commissioners asked if the double doors would open out. Rose verified that they would have to, in order to follow fire code. Rose also said that they have indeed done extensive work on the inside and are working on bringing everything up to code. Kelsey then asked about the colors chosen for the awning and the brick color. Commissioner found that the shades chosen were exact matches for the Historic Preservation Color Palette. McEwin said that since the awning is fabric the color would most closely resemble the Roycroft Pewter color and that the awning itself would be very close in style and size to neighboring buildings awnings. McEwin then showed Commissioners pictures of the Commercial doors that they would be using for the building.
